**The centers provide for the basic needs of orphans and widows through feeding programs, but also focus on community development programs with long-term sustainability. Six centers operate in the rural areas outside of Lilongwe, the capital city in central Malawi. Programs are community based, operated by Ministry of Hope, Malawi (a Malawi-based NGO) in conjunction with village leadership and volunteers. Food is raised at the centers, supplemented with purchased food as needed. Increasing emphasis is on development programs and income generating projects that will allow the community to provide for their members.**
