**COMMUNITY BASED CENTERS**

**The centers provide for the basic needs of orphans and widows through feeding programs, but also focus on community development programs with long-term sustainability. Six centers operate in the rural areas outside of Lilongwe, the capital city in central Malawi. Programs are community based, operated by ministry of Hope, Malawi (a Malawi based NGO) in conjunction with village leadership and volunteers. Food is raised at the centers, supplemented with purchased food as needed. Increasing emphasis is on development programs and income generating projects that will allow the community to provide for their members.**

**MOBILE MEDICAL CLINIC PROJECT**

**Since 2008 Ministry of Hope has sponsored a mobile medical clinic in communities that would otherwise have limited access to any form of medical care. The clinic is staffed by a medical director, physician assistants, nurses, volunteers from U.S. churches and service groups. The Mobile Medical Clinic has been registered and approved to operate by the Malawian government. A clinic bus transports staff, testing equipment and a mobile pharmacy on monthly visits to MOH communities. The clinics provide basic services such as physical exams, malaria testing, drugs such as anti-malarials, antibiotics and analgesics, and vitamins.**
